President's Scholarship	25-50% of tuition – see grid below	None required	Awarded to all new students with appropriate SAT/ACT scores plus 3.5 high school GPA; awarded for a maximum of 8 semesters; student must be enrolled full-time; requires 3.2 Taylor cumulative GPA to renew scholarship.
Dean's Scholarship	10-20% of tuition – see grid below	None required	Awarded to all new students with appropriate SAT/ACT scores plus 3.5 high school GPA; awarded for a maximum of 8 semesters; student must be enrolled full-time; requires 3.2 Taylor cumulative GPA to renew scholarship.
Christian Leadership Scholarship	25% of tuition	Admissions application and interview by January 15; extra interview with Director of Student Leadership in February	Awarded to 20 incoming freshmen with exceptional, demonstrated leadership skills; awarded for a maximum of 8 semesters; student must be enrolled full-time; requires 2.6 Taylor cumulative GPA, good citizenship standing, and participation in campus leadership opportunities to renew scholarship.
Student Leader Award	10% of tuition	Admissions application and interview by January 15; extra interview with Director of Student Leadership in February	Awarded to incoming freshmen not selected for the Christian Leadership Scholarship; award is for one year only.

Ethnic Student Scholarship	10-25% of tuition	Scholarship application submitted to Admissions Office by April 1	Awarded to 24 incoming students who demonstrate ability to contribute to cultural diversity; awarded for a maximum of 8 semesters; student must be enrolled full-time; requires satisfactory academic progress to renew scholarship.
International Student Scholarship	10-25% of tuition	None required	Awarded to 16 incoming students who demonstrate ability to contribute to cultural diversity; awarded for a maximum of 8 semesters; student must be enrolled full-time; requires satisfactory academic progress to renew scholarship.
Athletic Scholarships	Amounts vary	None required	Awarded at the direction of the coach; awarded for a maximum of 8 semesters; student must be enrolled full-time; requires 2.0 and continued team participation to renew scholarship.
Music Scholarships	Amounts vary	Audition with music department	Awarded at the direction of the Music Department Chair; awarded for a maximum of 8 semesters; student must be enrolled full-time; requires 2.0 and continued participation in the music program to renew scholarship.
Theatre Scholarship	Amounts vary	None required	Awarded at the direction of the theatre program faculty; awarded for a maximum of 8 semesters; student must be enrolled full-time; requires 2.0 and continued participation in the theatre program to renew scholarship.
Church Matching Grant Program	Maximum match of \$500/semester or \$1,000/year	Church Matching Grant pledge form must be submitted by church by March 10; actual full-year church gift must be received by June 1	Taylor matches church's gift dollar for dollar up to maximum match; awarded on an annual basis (church must submit pledge form and gift each year).

Dollars for Scholars Matching Grant	Maximum match of \$500/student/year	No deadline but Dollars for Scholars local chapter must submit matching form with their gift	Taylor matches the Dollars for Scholars local chapter's gift dollar for dollar up to a maximum of \$500/student/year. If student receives gifts from more than one chapter, Taylor's total match of all gifts will not exceed \$500.
Indiana Incentive Grant	10% of tuition	FAFSA must be filed by March 10	Student must receive HEA and FOC awards from Indiana; student must be enrolled full-time.
Taylor's 21 st Century Scholar Award	10% of tuition	FAFSA must be filed by March 10	Student must receive 21 st Century Scholarship from Indiana; student must be enrolled full-time.
Taylor's Lilly Community Scholar Award	Up to on-campus room & board costs	None required	Student must receive Indiana Lilly Community Scholarship and live on campus; any other scholarships or grants received by the student in addition to the Lilly Scholarship will reduce this grant.
Taylor General Grant	Amounts vary	FAFSA must be filed by March 10	Student must demonstrate financial need according to the FAFSA; annual amount will vary depending on the FAFSA.
Taylor Endowed & Annual Scholarships	Amounts vary	FAFSA must be filed by March 10	Students must meet various criteria stipulated by donors; generally must also demonstrate financial need according to the FAFSA.
