

2025-26 CHURCH MATCHING GRANT PLEDGE FORM (For Undergraduate Students only)

Award Information

Taylor University will match the church's gift dollar-for-dollar up to a maximum of \$1,000 per semester or \$2,000 for a full year per student, provided that:

- 1. This pledge form is received by April 1, 2025
- 2. The church's gift for the entire academic year is received by July 1, 2025. Be advised that monies received after July 1, 2025 will be applied to the student's account without a match.

Taylor will not match more than the original amount pledged, so estimate generously. Dependents of a full time Taylor employee are not eligible for the Taylor match; therefore, in that case, the church gift will be applied to housing and food costs.
